**Citizens Presentation:** (Limited to 3 minutes)

This item provides the opportunity to address the City Council on any matter whether or not it's posted on the agenda. However, in accordance with the Texas Open Meetings Act, Section 551.041, the Council cannot discuss, deliberate, or take any action on matters not listed on the agenda. At this time, the Council will receive citizen comments, and if necessary, may refer the matter to City staff for research, resolution or referral to Council on a future agenda.

**Item #1:** Discuss and consider taking action to adopt Ordinance 2017-09-002 adopting a tax rate to be levied for 2017 sufficient to provide the tax revenues required by the City.

This year's levy to fund maintenance and operations expenditures exceeds last year's maintenance and operations tax levy.

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

THE TAX RATE WILL EFFECTIVELY BE RAISED BY 0.60 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$13.90.

**Item #2:** Discuss and consider taking action to adopt Ordinance 2017-09-003 adopting a budget for the Fiscal Year of October 01, 2017 through September 30, 2018 prepared by the City Manager and submitted to the City Council. This budget will raise more total property taxes than last year's budget by \$12,844 or 1.11%, and, of that amount, \$6,268 is tax revenue to be raised from new property added to the tax roll this year

**Item #3:** Discuss and consider taking action to adopt Resolution 2017-09-001 approving Diboll Police Department's grant application number 3345101 for body worn video evidence storage system to be submitted to the governor of Texas.


**Adjournment**
