**AN ORDER DECLARING THE

WHEREAS, the City Council has today considered the returns of the Special Election held on May 6, 2023, for the approval of the propositions as set forth above to amend the Home Rule Charter; and

WHEREAS, the City Council finds, that the Canvassing Committee has tabulated the results of said Special Election and certified such tabulation for the City Council, and that there were 332 votes cast at said Special Election, and that such tabulation is correct;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DIBOLL, TEXAS: That all of the findings contained in the preamble of this Resolution are found to be true and are adopted as findings of fact.
