

DRIVING SAFETY COURSE (DEFENSIVE DRIVING) INFORMATION
READ INSTRUCTIONS CAREFULLY - (Failure to do may void your request.)

The Court shall defer proceedings and allow you 90 days to present evidence that subsequent to the alleged offense, you have successfully completed a DRIVING SAFETY COURSE approved by the Texas Dept. of Public Safety, IF;

1. On or before your appearance date, you enter a plea of NOLO CONTENDERE or GUILTY and present to the Court a written request to take the course: (the proper form is provided in the request and affidavit section below)
2. You have a valid Non-Commercial Texas Driver's License or permit
3. You have not taken the course for dismissal of a traffic citation within 12 months prior to offense date and you submit a Sworn Affidavit to that effect; (the proper form is provided in the request and affidavit section below)
4. You were not charged with the offense of speeding 25 MPH over the posted limit, fleeing, reckless driving, or offense involved in accident with damage to vehicle including hit & run.
5. You pay the Driving Safety School special request fee of \$145.00 by money order or cashier's check. No personal checks will be accepted. Payment can also be made in person or online at www.cityofdiboll.com
6. You MUST furnish proof of liability insurance to the court.
7. Confirm Driving Safety Course Approval with the Court before taking a Driving Safety Course.

Once Approved: Within 90 Days; you must supply the Court with the DSC CERTIFICATE OF COMPLETION. The court Copy must be signed and sent to the court. When the Court has accepted the Certificate, the charge will be dismissed. However, IF YOU FAIL TO COMPLY WITHIN 90 DAYS, additional fines, fees, and cost may be added to your case in addition to a warrant for your arrest.

DRIVING SAFETY COURSE REQUEST AND AFFIDAVIT
(✓ PLEA & SIGN BEFORE NOTARY)

I hereby enter a plea of _____ Nolo Contendere _____ GUILTY and waive my right to trial. I request the right to take a Driving Safety Course approved by the Texas Dept. of Public Safety. I have enclosed \$145.00 (or \$170.00 for school zone) that is required by the Court. I understand that I have 90 days from the date the citation was issued to return my Certificate of Completion to the Court. I have also enclosed my proof of insurance. Failure to follow all instructions will automatically void any request for DDC.

I swear that I have not taken a Driving Safety Course in the last year for dismissal of a traffic citation which I am presently making request.
