All in Favor, none opposed, motion carries.

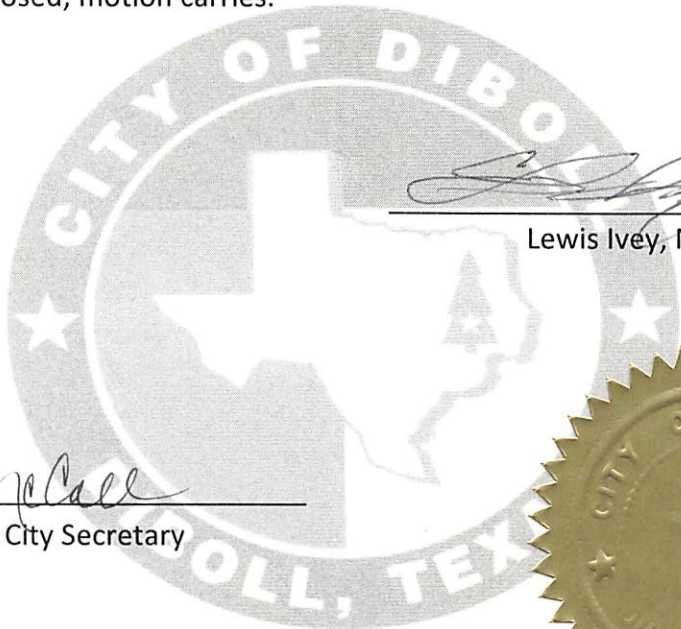
**Item #5:** Discuss and consider when and how to reopen City Hall, while following COVID-19 restrictions.
